## **BUY/SELL Credits Procedure**

1. The maximum amount of CREDITS that a producer can BUY/SELL in any one 12 month period is **10%** of a producer's allotted CDQ. *(Effective February 1, 2014)*
2. Producers may BUY or SELL kilograms up to +5/-15 days
3. The minimum amount of any BUY/SELL is fixed at 25/kgs.
4. The application deadline is 1:00 PM on the 25<sup>th</sup> day of the month. If the 25<sup>th</sup> day of the month is not a business day, then the application deadline is **1:00 PM** on the last business day prior to the 25<sup>th</sup> day of the month.
5. The effective date is either the first day of the current month or the first day of the next month. If an effective date is NOT given on the application form, the BUY/SELL CREDIT will be processed for the first day of the month following the application deadline.
6. CDQ Buy/Sell Credit Application Forms must not be faxed or emailed to KPMG. This automated system is for Producers submitting a Quota Exchange application only. Any forms submitted to KPMG will not be received or reviewed by the BCMMB until after the Buy/Sell Credits Application deadline.
7. A producer must contact another producer to arrange for a BUY/SELL of CREDITS between them. Each producer will complete to appropriate portions on the application form and one producer will submit the completed form to the BCMMB by mail, email, or facsimile. Buyer & Seller Credit Registries are also available on the BCMMB website and are a valuable resource for producers needing to Buy (overshipping) or Sell (undershipping) Credits.
8. The monetary value placed on the BUY/SELL of CREDITS and recorded on the application is set by the two producers. The Board will not approve if it can be shown that the producer BUYING the CREDITS did not complete the monetary transaction by the agreed upon payment date.
9. A producer buying CREDITS will see an increase in the "**CREDITS available over**" for the effective month.
10. A producer selling CREDITS will see an increase in the "**CREDITS available under**" for the effective month.

## **Transfer Applications**

Producers completing a family or name change transfer must submit a CDQ Name Change Transfer Application. The completed application must be received by the BCMMB one full month prior to the effective date (e.g., deadline of March 1, 2018 for a quota transfer effective April 1, 2018).
